<u>RESOLUTION/ORDINANCE REGARDING</u> APPROVAL OF AMENDED TY 2023 TAX LEVY

WHEREAS, the Board of Education of the LaMoille Community Unit School District No. 303 has heretofore adopted a Levy for Tax Year 2023 and has filed a Certificate of Tax Levy with the appropriate County authorities; and

WHEREAS, the Levy heretofore filed does not reflect the intention of the Board to raise sufficient revenue, and does not raise sufficient revenue, to meet the District's financial needs; and

WHEREAS, legislation is currently pending that, if adopted into law, would permit the Board to approve an amended Levy and submit the amended levy to the appropriate County authorities, to supersede the Tax Year 2023 Levy heretofore adopted, such that a sufficient amount of revenue shall be raised in Tax Year 2023 to meet the District's financial needs.

BE IT RESOLVED and ordained by the Board of Education of the LaMoille Community Unit School District No. 303 as follows:

<u>SECTION 1</u>: The foregoing recitals are incorporated herein by this reference.

SECTION 2: That, subject to pending legislation that will permit the Board to submit an amended Levy to the County authorities (the "Pending Legislation") being adopted into law, the Board directs that the Amended Lamoille CUSD #303 Tax Year 2023 Tax Levy, attached hereto and made a part hereof, which shall supersede the Tax Year 2023 Levy heretofore adopted, shall be adopted by the Board and shall be submitted to the appropriate County authorities.

SECTION 3: The Board authorizes the Board President, Secretary and District Superintendent to take such actions and execute such documentation and to submit such documentation to the appropriate County authorities, once this Resolution shall be in full force and effect as set forth in Section 5 below, as may be necessary to give effect to this Resolution.

SECTION 5: This Resolution shall be in force and effect upon the latter of its adoption by the Board and the adoption of the Pending Legislation into law.

RESOLUTION/ORDINANCE AUTHORIZING PETITION FOR COURT ORDER APPROVING AMENDED TY 2023 TAX LEVY

SECTION 3: The Board directs that the Administration file a Petition for Writ of Mandamus or otherwise appropriate Petition with the appropriate County Court authorities seeking approval of the Amended Levy and providing direction to the appropriate County authorities that they take any and all actions necessary to extend taxes on behalf of the District based upon said Amended Levy.

<u>SECTION 4</u>: The Board authorizes the Board President, Secretary and District Superintendent to take such actions and execute such documentation and to submit such documentation to the appropriate Court and County authorities, as may be necessary to give effect to this Resolution.

SECTION 5: This Resolution shall be in force and effect upon its adoption.
